

**OFFICIAL SWEEPSTAKES RULES**  
**2018-19 Broadway Las Vegas Ticket Give-Away**  
**March 1- July 30, 2018**  
**Drawing date: July 31, 2018**

NO PURCHASE NECESSARY TO ENTER OR WIN.

**SWEEPSTAKES DESCRIPTION:**

The Broadway Las Vegas Series Sweepstakes (“Sweepstakes”) will begin on March 1, 2018 and end on July 30, 2018 (“Sweepstakes Period”). This Sweepstakes will be conducted exclusively online. One (1) grand prize winner will be awarded 2 tickets to ten Broadway shows in the 2018-19 season at The Smith Center for the Performing Arts.

**HOW TO ENTER:**

Legal residents of the U.S. who are 18 years of age or older, and reside within the continental United States will be able to take part in this Sweepstakes. To participate in the Sweepstakes, participants must do the following:

1. Participants must enter their information in the Form located at <https://www.thesmithcenter.com/broadwaysweepstakes/>
2. Upon entering the Sweepstakes website, participants are to follow the on-screen instructions, including entering their name, date of birth, address, phone number, email address, and any optional or additional contact information, as requested, to register for a chance to win.
3. All Internet entries must be received by 11:59pm PST on July 30, 2018 or they will be void.
4. One entry per person per email address is allowed during the Sweepstakes Period.
5. In the event of a dispute regarding the identity of a participant’s online entry, the entry will be deemed to have been made by the authorized holder of the e-mail account at the time the entry was made.

**ELIGIBILITY RESTRICTIONS:**

1. Employees of The Smith Center, its officers, directors, subsidiaries, affiliates, advertisers, general sponsors, promotional partners, members of the immediate families (defined as spouse, child, sibling, parent, or grandparent), and members of the households (whether related or not) of any of the above are NOT eligible to participate or win in this Sweepstakes.

2. Persons who have won a prize in another sweepstakes or promotion of any kind from The Smith Center within the thirty-day (30) period immediately preceding the start date of this Sweepstakes are not eligible to participate.

3. Participants agree to abide with any applicable federal, state, local laws and regulations.

**PRIZES:**

1. One (1) grand prize winner will be awarded a prize. The prize will include the following: 2 tickets to ten Broadway shows in the 2018-19 season at The Smith Center for the Performing Arts. Blackout dates may apply. Tickets and seating are subject to availability and will be booked at the same time. No cancellations. Tickets cannot be exchanged. Transportation to and from the venue, souvenirs, and incidentals will not be provided by The Smith Center and will be the responsibility of the winner and his or her guest.

2. No substitution of prize is offered, no transfer of prize to a third party is permitted and non-cash prizes may not be redeemed for cash value, except as determined by The Smith Center management and/or the sponsor in its sole discretion.

3. All Sweepstakes winners must sign and date official Smith Center release and waiver forms as requested. Failure to do so will result in the winner's forfeiture of the prize.

4. Prizes will be awarded only upon winner verification and final approval by The Smith Center or if the prize notification or prize is returned undeliverable, that prize will be forfeited and if time permits, at the discretion of the Sweepstakes sponsor / and or Sweepstakes administrator, an alternate entrant will be selected as the winner by random drawing from among the remaining entries.

**EXECUTION:**

After completing the registration process, qualified entrants will be eligible for a chance to win the grand prize.

2. One (1) grand prize winner will be selected by random drawing from among all eligible entries received electronically. The grand prize winner will be notified by email on or about July 31, 2018, and provided with instructions for claiming their prize.

3. All decisions made by The Smith Center management regarding any aspect of this Sweepstakes are final.
